The Applicant(s) hereby applies / apply for the opening of a custody account, hereinafter referred to as S-Deposito. The account may be held as an individual custody account or, if a second applicant is indicated, as a joint custody account. Art. 143ff of the Swiss Code of Obligations (OR) on solidarity shall apply in the latter case. Further details are specified in point 3 of the Contractual Terms and Conditions for Collective Custody.

Details of the contract

An S-Deposito account will be set up for the Applicant(s) in the form of collective safekeeping in Swiss duty-free warehouses, in which silver of at least 999.9 grade is traded in the form of silver granules from certified production.

The annual custody account fee is 2 oz. silver (up to half a talent) or 4 oz. silver (from half a talent upwards). This is calculated semi-annually in advance and deducted from the holding. For clients domiciled in Switzerland, value added tax will be added. This covers any number of barter transactions, as well as the electronic retrieval of the custody account statement.

For safekeeping, 1 % or 0.8 % (from 30 talents) of the silver held in safekeeping for the applicants is charged annually and deducted from the holding every six months for the previous half-year. For clients domiciled in Switzerland, value added tax will be added.

The aforementioned conditions depend on the value of the selected Target Investment Amount (TIA) and the completion of the minimum deposits, which are specified in each case in the S-Deposito Purchase Agreement. Subsequent increases of the TIA, including the completion of the minimum deposits, will automatically lead to an adjustment of the fees as of the following month in the event of overruns. Each TIA increase is associated with the recalculation of the agreed commission (a standard 5 %, from 30 talents upwards 1.5 %).

Instructions on revocation

Right of revocation

You have the right to withdraw from this contract within fourteen days without giving any reason. The revocation period is fourteen days from the date of conclusion of the contract. In order to exercise your right of revocation, you must inform us (BB Wertmetall AG, Service Center, Solothurnstrasse 1, CH-2504 Biel/Bienne, SWITZERLAND, tel.: +41 (0)62 892 48 48, e-mail: service@bb-wertmetall.ch) by means of a clear declaration (e.g. a letter sent by post or an e-mail) of your decision to withdraw from this contract. You can use the sample withdrawal form from the website https://bb-wertmetall.ch/widerruf for this purpose, but it is not mandatory. To comply with the revocation period, it is sufficient for you to send the notification of your exercise of the right of revocation before the expiry of the revocation period.

Consequences of revocation

If you withdraw from this contract, we must immediately repay you all payments we have received from you, including the delivery costs (with the exception of the additional costs resulting from the fact that you have chosen a type of delivery other than the cheapest standard delivery offered by us), at the latest within fourteen days from the day on which we received the notification of your withdrawal from this contract. For this repayment, we will use the same means of payment that you used for the original transaction, unless expressly agreed otherwise with you; in no case will you be charged for this repayment.

Excluded from the revocation

A right of revocation does not exist in the case of contracts for the delivery of goods whose price depends on fluctuations on the commodity and foreign exchange market and over which the entrepreneur has no influence. With regard to the silver sold by BB Wertmetall AG under this contract, there is therefore no right of revocation.
