Scope and limitations

The authorised representative(s) may in particular:

- Buy and sell precious metals on the account of the grantor(s)
- have counter-values from sales transferred to themselves or third parties or have precious metals delivered to themselves or third parties
- Receive and acknowledge statements of account and draft and receive communications
- Request or change access data for individual online access of the aforementioned contracts

The power of attorney does not entitle the holder to the following:

- Concluding further contracts in the name of / on the account of the grantor(s)
- Termination and dissolution of contracts without the involvement of living grantors of power of attorney
- Granting of sub-authorisations

Period of validity

The power of attorney is unlimited and does not expire in the event of death, declaration of disappearance, loss of capacity to act or bankruptcy of the grantor(s). However, the power of attorney may be revoked in writing at any time by at least one of the grantors or by all heirs jointly. The power of attorney remains valid until BB Wertmetall AG receives the revocation. In the event of revocation by only one or some of the heirs, the power of attorney shall expire only for the revoking party/parties. In this case, authorised representatives may only make further dispositions in conjunction with the revoking party/parties. BB Wertmetall AG may request that the revoking person(s) identify themselves as heir(s).

Notes

The power of attorney must always be granted jointly by all applicants / contracting partners of the aforementioned contracts. Powers of attorney are obliged to protect the interests of the heirs after the death of the grantor, to obtain their instructions from and to render account to the heirs. All legal relationships with BB Wertmetalll AG are subject exclusively to Swiss material law. To the extent permitted by law, the place of performance and exclusive place of jurisdiction for all proceedings shall be the registered office of BB Wertmetal AG in Lenzburg.
